PARTIAL RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS PARTIAL RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Partial Release") is made as of March 14, 2006 ("Effective Date") by and among Russ Berrie and Company, Inc., a New Jersey corporation, Kids Line, LLC, a Delaware limited liability company, Sassy, Inc., an Illinois corporation, with their principal office at 111 Bauer Drive, Oakland, New Jersey 07436 (collectively, the "Grantors," and each, individually, a "Grantor"), and California KL Holdings, Inc., in its capacity as Collateral Agent for the Deferred Payout Sellers (the "Agent", in such capacity, "Grantee"). Capitalized terms used by not defined herein shall have the meanings given thereto in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Membership Interest Purchase Agreement (the "Acquisition Agreement"), dated December 15, 2004, among Russ Berrie and Company, Inc., a New Jersey corporation (the "Purchaser"), Kids Line, LLC, a Delaware limited liability company ("Company"), and the various sellers party thereto (including the Deferred Payout Sellers), the Purchaser purchased all of the outstanding membership interests and all the outstanding warrants to purchase membership interests of the Company;

WHEREAS, to secure certain of their obligations under the Acquisition Agreement, Grantors entered into that certain Trademark Security Agreement by and among Grantors and Grantee dated as of December 15, 2004 (as amended and in effect on the date hereof, the "Trademark Security Agreement"), pursuant to which each Grantor granted to Grantee a continuing security interest in and to all of such Grantor's right, title and interest in, to and under the Trademark Collateral

WHEREAS, Grantee has agreed to release the Trademark Collateral of Russ Berrie and Company, Inc.;

WHEREAS, the Schedule to the Trademark Security Agreement inadvertently included certain assets of Russ Australia Pty Limited, which entity was not a Grantor under the Trademark Security Agreement;

WHEREAS, Grantee acknowledges that it has no security interest in any assets of Russ Australia Pty Limited (the "Purported Trademark Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby (i) releases Russ Berrie and Company, Inc. from its obligations under the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against any Trademark Collateral of Russ Berrie and Company, Inc.; (iii) confirms that the Trademark Security Agreement does not apply to Russ Australia Pty Limited and (iv) confirms that it has no security interests against any Purported Trademark Collateral of Russ Australia Pty Limited.

Grantee represents and warrants that: (i) it has the full power and authority to execute this Partial Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral of Russ Berrie and Company, Inc., nor has it attempted to do so with respect to any security interest it may have thought it had against the Purported Trademark Collateral of Russ Australia Pty Limited; (iii) to


the best of its knowledge, it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register the foregoing, or any trade name or assumed name of Russ Berrie and Company, Inc. or of Russ Australia Pty. Limited, other than those of the foregoing set forth on Schedule I (attached hereto), in any jurisdiction throughout the world; and (iv) to the best of its knowledge, Schedule II attached hereto sets forth a complete and correct list of all the filings made by or, to its knowledge, on behalf of Grantee to record or otherwise evidence any security interest it has against the Trademark Collateral of Russ Berrie and Company, Inc. or against the Purported Trademark Collateral of Russ Australia Pty. Limited in any jurisdiction throughout the world (other than such filings made in the United States Patent & Trademark Office).

Grantee shall promptly, at Grantors' expense, take all further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Partial Release.
