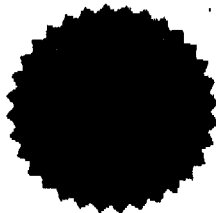


FIRST: The name of the corporation is ComputerRepair.com, Inc.
