**III.**


The foregoing Amendment was duly adopted on March 1, 2006.

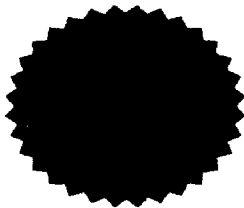


