TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (together with the Exhibit A hereto, this "Agreement") is entered into as of July __, 2006 by and among UCB, Inc. (f/k/a UCB Pharma, Inc.), a Delaware corporation ("Assignor"), and Adams Respiratory Operations Sub, Inc., a Delaware corporation ("Assignee"). Assignee and Assignor are referred to hereinafter individually as a "Party" and collectively as the "Parties".

RECITALS:

A. Assignor is the owner of the trademark NOTHING LASTS LONGER, intended for use in connection with printed matter, namely newspapers, brochures and newspapers published for patients, consumers, health care providers, and pharmacists about pharmaceutical preparations used to treat cough and colds, subject of the pending trademark application described on Exhibit A attached hereto (the mark NOTHING LASTS LONGER and the pending federal trademark application described on Exhibit A are hereafter cumulatively referred to as the "Trademark"); and

B. Assignee desires to obtain all of Assignor's right, title and interest in and to the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

(1) Assignor assigns, transfers and conveys to Assignee and its successors, assigns and legal representatives, all of Assignor's right, title and interest in and to the Trademark, including the federal trademark application therefor and all common law rights therein, together with the goodwill of the business symbolized thereby, and including without limitation Assignor's right to sue for and seek remedies against present and future infringements of any or all of the foregoing and rights of priority and protection of interests therein under the laws of any jurisdiction.

(2) This Agreement excludes, and Assignor specifically disclaims, all express, implied and statutory representations and warranties in favor of Assignee, its affiliates, its customers and all other third parties with respect to the Trademark and the goodwill of the business symbolized thereby.

(3) Assignee acknowledges and agrees the Trademark and the goodwill of the business symbolized thereby are assigned to Assignee "AS IS" and that Assignor has no continuing obligation to prosecute or maintain the federal trademark application for the Trademark as identified by Exhibit A.

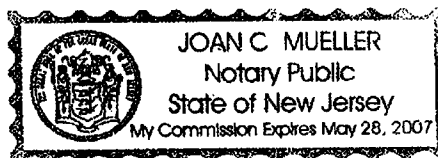
