ASSET PURCHASE AGREEMENT

This Asset Purchase Agreement (this "Agreement") is entered into as of November 29, 2005, by and among: CLEARSNAP, INC., a Washington corporation (the "Seller"); JEFFREY MARVIN WINSTON, and SARAH HOENSELAAR WINSTON, (each a "Shareholder" and collectively, the "Shareholders"); and CLEARSNAP HOLDING, INC., a Washington corporation, and its assigns (the "Buyer") and ON POINT PROPERTIES, LLC, a Utah limited liability company, (the "Guarantor"). Certain capitalized terms used in this Agreement are defined in Exhibit A.

Recitals

- A. The Shareholders own shares of common stock of Seller, which constitute all of the total issued and outstanding capital stock of Seller, and are the sole shareholders of Seller.
- B. Seller desires to sell, and Buyer desires to purchase, the Assets of Seller for the consideration and on the terms set forth in this Agreement.
- C. Due to the fact that Buyer is a newly formed Washington corporation with limited assets, Guarantor desires to guarantee certain obligations of the Buyer.

Agreement

The parties to this Agreement, intending to be legally bound, agree as follows:

ARTICLE I

SALE OF ASSETS; RELATED TRANSACTIONS

1.1 Sale of Assets.

(a) Assets. Upon the terms and subject to the conditions set forth in this Agreement, the Shareholders and Seller shall cause to be sold, assigned, transferred, conveyed and delivered to Buyer, at the Closing (as defined below), and Buyer shall purchase and acquire from Seller, free and clear of any Encumbrances other than Permitted Encumbrances, all of Seller's right, title and interest in and to the Assets. For purposes of this Agreement, "Assets" shall mean and include all of the properties, rights, interests and other tangible and intangible assets of Seller (wherever located and whether or not required to be reflected on a balance sheet prepared in accordance with GAAP), including any assets acquired by Seller during the Pre-Closing Period and any other assets that are owned by any of the Shareholders or any other Related Person and that are needed for the conduct of, or are useful in connection with, the business of Seller; *provided, however*, that the Assets shall not include any Excluded Assets. Without limiting the generality of the foregoing, the Assets shall include:

2.13 Intellectual Property Assets.

(a) Intellectual Property Assets. The term "Intellectual Property Assets" means all intellectual property owned or licensed by Seller (as licensor or licensee) in which Seller has a proprietary interest, including:

(i) Seller's name, all assumed fictional business names, trade names, registered and unregistered trademarks, service marks and applications (collectively, "Marks");

(ii) all patents, patent applications and inventions and discoveries that may be patentable (collectively, "Patents");

(iii) all registered and unregistered copyrights in both published works and unpublished works (collectively, "Copyrights");

(iv) all rights in mask works;

(v) all know-how, trade secrets, confidential or proprietary information, customer lists, Software, technical information, data, process technology, plans, drawings and blueprints (collectively, "Trade Secrets"); and

(vi) all rights in internet web sites and internet domain names presently used by Seller (collectively "Net Names").

(vii) the Intellectual Property Assets are all those necessary for the operation of the Business as it is currently conducted. Seller is the owner or licensee of all right, title and interest in and to each of the Intellectual Property Assets, free and clear of all Encumbrances, and has the right to use without payment to a Third Party all of the Intellectual Property Assets, other than payment in the Ordinary Course of Business to artists and illustrators;

(viii) Seller does not have executed written Contracts with former and current employees that assigns to Seller all rights to any inventions, improvements, discoveries or information relating to the Business;

(b) Patents. With respect to Patents:

(i) Part 2.13 of the Disclosure Schedule contains a complete and accurate list and summary description of all Patents, and will be updated prior to or at Closing;

(ii) all of the issued Patents are currently in compliance with formal legal requirements (including payment of filing, examination and currently scheduled maintenance activities and maintenance fees and proofs of working or use), are valid and enforceable, and are not subject to any maintenance fees or taxes or actions falling due within ninety (90) days after the Closing Date;

(iii) no Patent has been or is now involved in any interference, reissue, reexamination, or opposition Proceeding. To Seller's Knowledge, there is no potentially interfering patent or patent application of any Third Party;

(iv) except as set forth in Part 2.13(b)(iv) of the Disclosure Schedule, (A) no Patent is infringed or, to Seller's Knowledge, has been challenged or threatened in any way and (B) none of the products manufactured or sold, nor any process or know-how used, by Seller infringes or is alleged to infringe any patent or other proprietary right of any other Person;

(v) all products made, used or sold under the Patents have been marked with the proper patent notice.

(c) Marks. With respect to Marks:

(i) Part 2.13 of the Disclosure Schedule contains a complete and accurate list and summary description of all Marks;

(ii) all Marks have been registered with the United States Patent and Trademark Office, are currently in compliance with all formal Legal Requirements (including the timely post-registration filing of affidavits of use and incontestability and renewal applications), are valid and enforceable and are not subject to any maintenance fees or taxes or actions falling due within ninety (90) days after the Closing Date;

(iii) no Mark has been or is now involved in any opposition, invalidation or cancellation Proceeding and, to Seller's Knowledge, no such action is threatened with respect to any of the Marks;

(iv) to Seller's Knowledge, there is no potentially interfering trademark or trademark application of any other Person;

(v) except as set forth on Disclosure Schedule Part 2.13(b)(iv), no Mark is infringed or, to Seller's Knowledge, has been challenged or threatened in any way. None of the Marks used by Seller infringes or is alleged to infringe any trade name, trademark or service mark of any other Person;

(vi) all products and materials containing a Mark bear the proper federal registration notice where permitted by law.

(d) Copyrights. With respect to Copyrights:

(i) It is the practice of Seller to rely on common law copyright only; it does not regularly register its works for copyright.

(e) Trade Secret. With respect to each Trade Secret:

(i) the documentation relating to such Trade Secret is current, accurate and sufficient in detail and content to identify and explain it and to allow its full and proper use without reliance on the knowledge or memory of any individual;

(ii) Seller has taken reasonable precautions to protect the secrecy, confidentiality and value of all Trade Secrets, however has not established a policy requiring each employee or contractor to execute proprietary information and confidentiality agreements;

(iii) Seller has good title to and an absolute right to use the Trade Secrets. The Trade Secrets are not part of the public knowledge or literature and, to Seller's Knowledge, have not been used, divulged or appropriated either for the benefit of any adverse claimant nor have been challenged or threatened in any way or infringe any intellectual property right of any other Person.

(f) Net Names. With respect to Net Names:

(i) Part 2.13 of the Disclosure Schedule contains a complete and accurate list and summary description of all Net Names;

(ii) all Net Names have been registered in the name of Seller and are in compliance with all formal Legal Requirements;

(iii) no Net Name has been or is now involved in any dispute, opposition, invalidation or cancellation Proceeding and, to Seller's Knowledge, no such action is threatened with respect to any Net Name;

(iv) to Seller's Knowledge, there is no domain name application pending of any other person which would or would potentially interfere with or infringe any Net Name;

(v) no Net Name is infringed or, to Seller's Knowledge, has been challenged, interfered with or threatened in any way. No Net Name infringes, interferes with or is alleged to interfere with or infringe the trademark, copyright or domain name of any other Person.


