**TERMINATION OF SECURITY INTEREST
(Trademarks)**

This **TERMINATION OF SECURITY INTEREST**, dated as of _____, 2006, is made by Deutsche Bank Trust Company Americas, as Collateral Agent (the "Collateral Agent").

WHEREAS, Smurfit-Stone Container Corporation, Smurfit-Stone Container Enterprises, Inc., and the other subsidiaries of Smurfit-Stone Container Corporation from time to time parties thereto, all Delaware corporations (collectively the "Grantor"), has granted to the Collateral Agent pursuant to that certain Trademark Security Agreement (U.S.), dated as of November 1, 2004, between Grantor and the Collateral Agent a security interest (the "Security Interest") in certain trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office, and all extensions and renewals thereof ("Trademarks");

WHEREAS, the Security Interest granted to the Collateral Agent was recorded at the United States Patent and Trademark Office on November 29, 2004 at Reel 003162 and Frame 0211; and

WHEREAS, the Collateral Agent has agreed to terminate and release (without recourse and without any representation or warranty) its Security Interest in the Trademarks set forth on Schedule A attached hereto;


NOW, THEREFORE, for good and valuable consideration, the Collateral Agent hereby terminates and releases (without recourse and without any representation or warranty) its Security Interest, and any right, title or interest of the Collateral Agent, in the following Trademarks:

1. all of the Grantor's Trademarks identified on Schedule A attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each Trademark identified on Schedule A attached hereto; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark identified on Schedule A attached hereto or (ii) injury to the goodwill associated with any Trademark identified on Schedule A attached hereto.
