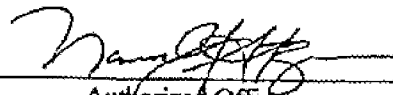
RESOLVED, that the Certificate of Incorporation of this corporation be amended by changing Article FIRST thereof so that, as amended, said Article shall be and read as follows:
