NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS


Reference is made to that certain Patent and Trademark Security Agreement, dated as of February 6, 2004 (the "Security Agreement") and recorded at the United States Patent and Trademark Office at Reel 3031 and Frame 0233 on August 23, 2004, by ZILA, INC., a Delaware corporation (the "Grantor"), in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION, acting through its Wells Fargo Business Credit operating division ("Wells Fargo").
