AND WHEREAS the Assignor and the Assignee have agreed that the Trade Marks shall be assigned by the Assignor to the Assignee.


NOW THIS ASSIGNMENT WITNESSETH as follows:-

AND it is further agreed that the Assignee will at his expense attend to recordal of this Assignment on the European Community and United States Trade Mark Registers.


