**TRADEMARK ASSIGNMENT**

**WHEREAS**, Razor USA LLC, a Delaware limited liability company (“Assignor”), owns, adopted, and/or, either directly or through a licensee, is using or intends to use the trademark RAZR in connection with mobile devices and other goods;

**WHEREAS**, Assignor has applied to register or has registered the trademark RAZR in the United States and internationally. A comprehensive list of pending and registered marks is attached hereto as **Exhibit A**.

United States: With respect to the United States, Assignor has applied to register the mark on the Principal Register of the United States Patent and Trademark Office as follows: (1) Application Ser. No. 78/750,841: a use-based application filed on November 9, 2005 with a claimed first use in commerce date of November 2004; and (2) Application Ser. No. 78/750,797: an intent-to-use application based on Assignor’s bona fide intent to use the trademark in connection with the goods identified in the application filed on November 9, 2005;

**WHEREAS**, Razor IP Sub LLC, a Delaware limited liability company (“Assignee”), desires to acquire the trademark RAZR in the United States and internationally, including Application Ser. Nos. 78/750,841 and 78/750,797 in connection with the goods set forth therein, and the business of Assignor in connection with which Assignor has a bona fide intent to use the trademark RAZR as set forth in Application Ser. No. 78/750,797; as well as the international trademark filings set forth in Exhibit A.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all right, title and interest in and to the trademark RAZR including Application Ser. Nos. 78/750,841 and 78/750,797 and the business of Assignor in connection with which Assignor has a bona fide intent to use the trademark RAZR as set forth in Application Ser. No. 78/750,797; as well as the international trademark filings set

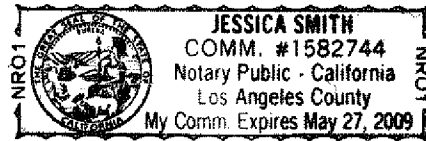
