INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT


WHEREAS, The Antigo Cheese Company (“Assignor”), a Wisconsin corporation, entered into an Asset Purchase Agreement dated June 5, 2006 by and among Assignor and The Blackfoot Cheese Company as Sellers, and Sartori Food Corporation as Buyer (the “Asset Purchase Agreement”), which included an assignment of all right, title, and interest in U.S. Trademark Registration No. 2,109,233 for the mark WISANTIGO (the “Trademark Registration”) as evidence by the description attached hereto as Exhibit A, including all goodwill associated therewith and the right to sue and collect damages for all past, present, and future infringements thereof, to Sartori Food Corporation, a Wisconsin corporation with a principal place of business at 107 Pleasant View Road, Plymouth, Wisconsin, 53073 (“Assignee”); and

WHEREAS, the parties desire to confirm the assignment of the Trademark Registration from Assignor to Assignee, including all goodwill associated therewith and the right to sue and collect damages for all past, present, and future infringements thereof, and to record confirmation of the assignment in the United States Patent and Trademark Office.


