NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:



representatives, as fully and entirely as if the same would have been held and enjoyed by Assignor if this Assignment had not been made.


