

## U.S. TRADEMARKS RELEASE OF SECURITY INTEREST

THIS RELEASE dated as of July 26, 2006, by Wachovia Bank, National Association, as Agent (as defined below) for the Lenders. Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

A. Reference is made to the Amended and Restated Credit Agreement dated as of March 8, 2005 (the "Credit Agreement"), by and among ENDURANCE BUSINESS MEDIA, INC., a Delaware corporation (the "Borrower"), ENDURANCE BUSINESS MEDIA HOLDINGS, LLC, a Delaware limited liability corporation (the "Parent"), WACHOVIA BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity, the "Agent") and Issuing Lender and WACHOVIA CAPITAL MARKETS, LLC, as lead arranger and sole bookrunner.

B. Reference is made to (i) the Collateral Agreement, dated as of January 14, 2004 (the "Collateral Agreement"), by and among the Borrower, each Guarantor party thereto and the Agent in favor of the Agent, as amended by the Master Amendment and Reaffirmation Agreement dated as of March 8, 2005 by and among the Borrower, each Guarantor party thereto and the Agent in favor of the Agent, (ii) the Trademark Security Agreement dated as of January 14, 2004 by Century Publishing Company, Inc. in favor of the Agent, (iii) the Trademark Security Agreement dated as of January 14, 2004 by Homes & Land, LLC in favor of the Agent, (iv) the Trademark Security Agreement dated as of January 14, 2004 by Homes & Land Affiliates, LLC in favor of the Agent, (v) the second Trademark Security Agreement dated as of January 14, 2004 by Homes & Land Affiliates, LLC in favor of the Agent and (vi) the Trademark Security Agreement dated as of December 10, 2004 by Frontiers Unlimited, Inc. in favor of the Agent (the agreements referred to in clauses (ii) to (vi) of this paragraph, collectively, the "Trademark Security Agreements"), pursuant to which, among other things, the parties thereto granted security interests to the Agent, for the benefit of certain secured parties named therein, in, among other things, the registered trademarks and pending trademark applications of the parties thereto set forth on Annex I hereto (the "Trademarks"), which security interests were recorded with the United States Patent & Trademark Office against certain trademarks at Reel 002794 Frame 0812 on February 17, 2004, Reel 002794 Frame 0825 on February 17, 2004, Reel 002794 Frame 0777 on February 17, 2004 and Reel 002998 Frame 0218 on December 28, 2004.

C. In connection with the termination of the Credit Agreement, the Borrower has informed the Agent of its desire to obtain the release of all right, title and interest of the Agent, the Lenders and each other grantee or beneficiary in and to the Trademarks granted under the Collateral Agreement and the Trademark Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks pursuant to the Collateral Agreement and the Trademark Security Agreements shall hereby terminate, including, without limitation, the Trademarks set forth on Annex I attached hereto, the debt secured thereby having been paid and satisfied in full and any right, title or interest of the Agent in such Trademarks shall hereby cease and become void.
