




TRADEMARK TRANSFER AND ASSIGNMENT

TRADEMARK SECURITY AGREEMENT

Trademark Security Agreement made this 2nd day of August, 1996 between Golden Bear International, Inc., a Florida corporation (the "Company") and Golden Bear Golf, Inc. (the "Secured Party").

WHEREAS, the Company has rights, title and interest in and to all of the certain trademarks that are identified in Annex A and B attached hereto and incorporated herein by reference (the "Trademarks").

WHEREAS, the Company and the Secured Party have entered into a Trademark License Agreement, dated as of June 7, 1996 (the "License Agreement"), wherein the Company granted to the Secured Party certain licenses to use the Trademarks

WHEREAS, as a part of transactions contemplated by the Reorganization Agreement, between the Company and the Secured Party and certain other parties thereto the Company is executing and delivering this Agreement and granting to the Secured Party a continuing security interest in all of the Licensed Marks (as defined in the License Agreement, as such term may be amended from time to time to include rights to additional trademarks or otherwise), and other Collateral (as defined herein) subject to the terms and conditions of this Agreement. The Licensed Marks currently include those registered trademarks identified in Annex B attached hereto and those common law trademarks included in Annex A hereto.

NOW, THEREFORE, in consideration of the foregoing and for good and valuable consideration (including the receipt of 1,320,000 shares of Class B Common Stock, par value \$0.01 per share, of the Secured Party as part of the Reorganization), the receipt and adequacy of which is hereby acknowledged, the Company and the Secured Party agree as follows:

1. Defined Terms.

"Bankruptcy Event" means (a) the Company shall make an assignment for the benefit of creditors, file a petition in bankruptcy, be adjudicated insolvent, petition or apply to any tribunal for the appointment of a receiver, custodian, or any trustee for it or a substantial part of its assets, or shall commence any proceeding under any bankruptcy, reorganization, arrangement, readjustment of debt law or statute of any jurisdiction, whether now or hereafter in effect, or the Company shall take any corporate action to authorize any of the foregoing actions; or there shall have been filed any such petition or application; or any such proceeding shall have been commenced against it which remains undismissed for a

period of sixty (60) days or more, or any order for relief shall be entered in any such proceeding, or the Company, by any act or omission, shall indicate its consent to, approval of or acquiescence in any such petition, application or proceeding or the appointment of a custodian, receiver or any trustee for it or any substantial part of any of its properties, or shall suffer any custodianship, receivership or trusteeship to continue undischarged for a period of sixty (60) days or more; (b) the Company shall admit in writing that it is not generally paying its debt as such debts become due; or (c) the Company shall have commenced any proceeding under any dissolution or liquidation law.

"Code" means the Uniform Commercial Code (or other similar applicable law governing security interests in personal property) from time to time in effect in any jurisdiction with respect to the security interest created hereby.

"Collateral" means the Trademark Collateral, all goodwill associated therewith, wherever located, and all Proceeds thereof.

"Event of Default" shall mean (a) any breach by the Company of any material provision of the License Agreement as determined in arbitration pursuant to Section 17 of the License Agreement, provided that the Company does not cure such breach within ninety (90) days after such determination; (b) any breach by the Company of any material provision of this Agreement, provided that the Company does not cure such breach within ninety (90) days after breach; (c) a Bankruptcy Event; (d) the formal declaration by the Company of a Wrongful Termination of the License Agreement or the occurrence of any events which would constitute a Wrongful Termination of the License Agreement, or (e) the commencement of any proceeding by any third party for foreclosure on the Collateral which remains undismissed for sixty (60) days or more, or the entry of any order for relief in any such proceeding.

"Lien" means any mortgage, lien, pledge, charge, title retention as security interest, or other security interest.

"Obligations" means all obligations and liabilities of the Company to the Secured Party, whether direct or indirect, absolute or contingent, due or to become due, whether monetary or non-monetary or whether now existing or hereafter incurred, which may arise under or out of the License

Agreement or this Agreement and the Secured Party's related rights thereunder or hereunder.

"Permitted Liens" means (i) Liens for taxes not yet subject to penalties for non-payment or the non-payment of which is being contested in good faith by appropriate proceedings, or (ii) statutory Liens to secure the payment of workers' compensation, pension, unemployment insurance or other social security benefits or employee obligations incurred in the ordinary course of business of the Company or its affiliates, but only to the extent related to payments not yet due or being contested in good faith by appropriate proceedings.

"Proceeds" means all "proceeds" as defined in the Code including, without limitation, any claim by the Company against third parties for past, present or future infringement or dilution of any of the Licensed Marks or for any injury to the goodwill associated with the use of any of the Licensed Marks and including without limitation, license royalties, income payments claims, damages and proceeds of suit.

"Retained Businesses" shall have the meaning ascribed to such term in the License Agreement.

"Trademark Collateral" means the Licensed Marks including, without limitation, the Licensed Marks set forth on Annex A and B, as well as any collateral in which a security interest is granted to the Secured Party pursuant to Sections 2, 4(g) and 4(h).

"Transferred Businesses" shall have the meaning ascribed to such term in the License Agreement.

"Wrongful Termination" shall mean, with respect to the License Agreement (a) the repudiation of the License Agreement by the Company, (b) the failure of the Company to respond to or otherwise contest any demand for termination made by the Secured Party in arbitration under paragraph 17 of the License Agreement as a result of the Company's failure to cure a breach of the License Agreement within the time allowed to do so, or (c) the issuance of a final order granting the Secured Party's demand for termination of the License Agreement as a result of a declared breach by the Company in an arbitration filed under paragraph 17 of the License Agreement, or a result of the Company's failure to comply with any interlocutory remedial orders granted in any such arbitration.

2. Grant of Security Interest. As collateral security for prompt and complete performance when due of the Obligations, the Company hereby grants to the Secured Party a continuing security interest in the Collateral. The parties acknowledge that those Trademarks defined as the "Retained Marks" in the License Agreement and expressly reserved to the Company thereunder are hereby expressly excluded from the foregoing grant of a security interest to the extent of such "Retained Marks," and the Secured Party shall not acquire any interest in or rights against such property or any of the proceeds thereof by virtue of this Agreement except as otherwise provided in 4(h).

3. Representations and Warranties. The Company hereby represents and warrants that, as of the date hereof:

(a) Corporate Power. The Company has the corporate power and authority and the legal right to grant the first priority continuing security interest on the Collateral pursuant to this Agreement and has taken all necessary corporate action to authorize its grant of the first priority continuing security interest on the Collateral pursuant to this Agreement.

(b) No Conflict. The execution, delivery and performance of this Agreement will not violate any provision of the Certificate of Incorporation and By-Laws of the Company or any intellectual property right, whether statutory or under common law, or any law, treaty, rule or regulation or determination of an arbitrator or a court or other governmental authority, in each case, applicable to or binding upon the Company or any of its property or to which the Company or its property is subject or any provision of any agreement, instrument or undertaking to which the Company is a party or by which the Company or any of the property owned by it is subject.

(c) No Consents. No consent or authorization of, filing with, or other act by or in respect of, any governmental authority or any other person is required in connection with the execution, delivery, performance, validity or enforceability of this Agreement other than recordation of this Agreement under applicable laws and regulations.

(d) Title; No Other Liens. Except for the Lien granted to the Secured Party pursuant to this Agreement, the Company owns each item of the Collateral free and clear of any and all Liens. No security agreement, financing statement or other public notice with respect to all or any part of the Collateral is on file or of record in any public office, except such as have been filed in favor of the Secured Party pursuant to this Agreement.

(e) Location of Company and Trademark Collateral. The chief place of business and chief executive office of the Company is 11780 U.S. Highway One, North Palm Beach, Florida 33408.

(f) Representations and Warranties in the License Agreement. All of the representations and warranties of the Company contained in the License Agreement are true and correct as of the date hereof.

(g) Perfected First Priority Security Interest. The security interest granted pursuant to this Agreement (i) upon completion of the filings and other actions in appropriate filing offices will constitute perfected first priority security interests in the Collateral in favor of the Secured Party and (ii) is enforceable as such against all creditors of and purchasers from the Company.

(h) Shared Marks. The only Shared Marks (as defined in Section 4(n)) material to the licensing business included in the Transferred Businesses as of the date hereof are listed on Annex C hereto. If the Company becomes aware of any additional Shared Marks it will amend Annex C hereto to include such Shared Marks.

4. Covenants. The Company covenants and agrees with the Secured Party that:

(a) Maintenance of Perfected Security Interest; Further Documentation. The Company shall maintain the security interest created by this Agreement as a first priority perfected security interest subject to no other Liens and shall defend such security interest against all claims and demands. At any time and from time to time, including upon any change of the Company's principal place of business, upon the written request of the Secured Party, the Company will promptly and duly execute and deliver such further instruments and documents and take such further action as the Secured Party may reasonably request for the purpose of obtaining or preserving the full benefits of this Agreement and of the rights and powers herein granted, including, without limitation, the filing of any financing or continuation statements under the Code or under any state, federal or foreign trademark laws. Any costs or expenses incurred in connection with the performance of the obligations set forth in the second sentence of this Section 4(a) shall be paid by the Secured Party.

(b) Maintenance of Records. The Company will keep and maintain at its own cost and expense satisfactory and complete records of the Collateral. The Company will mark its books and records pertaining to the Collateral to evidence this Agreement and the security interests granted hereby.

(c) Compliance with Laws, etc. The Company will comply in all material respects with all requirements of all laws applicable to the Collateral or any part thereof or to the operation of the Company's business to the extent necessary to prevent an impairment of the Lien granted hereby or the Secured Party's interest in the Collateral.

(d) Limitations on Dispositions of Collateral The Company will not directly or indirectly, sell, assign, transfer or otherwise dispose of any of the Collateral except in accordance with the terms of the License Agreement or this Agreement.

(e) Limitation on Liens on Collateral The Company (a) will not create, incur or permit to exist, (b) will defend the Secured Party against, and (c) will take such other action as is necessary to remove, in each case (a), (b) and (c), any Lien or claim on or to the Collateral, other than the Liens created hereby or Permitted Liens.

(f) Payment of Obligations The Company will pay and discharge or otherwise satisfy at or before maturity, or before they become delinquent, as the case may be, all taxes, assessments and governmental charges or levies imposed upon the Collateral or in respect of income or profits therefrom, as well as all claims of any kind (including, without limitation, claims for labor, materials and supplies) against or with respect to the Collateral. Nothing in this provision shall be deemed to require the Company to pay trademark filing, registration, maintenance and renewal fees, charges or taxes except as required under the License Agreement.

(g) Additional Collateral The Company agrees that it is also hereby conveying to the Secured Party a first priority security interest in any Licensed Marks which may hereafter be adopted or acquired by the Company for the benefit of the Secured Party as its licensee during the term of the License Agreement, and such Licensed Marks shall be deemed to be included within the definition of "Trademark Collateral" and shall be included in the grant of the security interest pursuant to Section 2 automatically from the date upon which the Company first obtains trademark rights in such Licensed Marks without further action of the parties. Upon reasonable request of the Secured Party, and subject to the Secured Party's payment of all expenses and fees of the Company, the Company further agrees to execute and file such documents and instruments and to take such other and further actions as may be reasonably required to amend the list of Licensed Marks set forth in Annex A to reflect all of the Company's common law trademark and Annex B hereto to reflect all of the Company's registrations with respect to the Licensed Marks as in effect from time to time, provided that such amendment shall not be a condition to the inclusion of any new Licensed Marks as additional security under this Assignment.

(h) Shared Marks. The Company hereby agrees that with respect to any Licensed Marks listed on Schedule B to the License Agreement which are also used by the Company in connection with the Retained Businesses ("Shared Marks"), at the request and expense of the Secured Party, the Company shall, as promptly as practicable under the circumstances, take all appropriate action and execute any and all documents and instruments necessary or desirable in order to obtain separate trademark registrations for the Shared Marks solely for those goods and services used in connection with the Transferred Businesses ("Segregated Registered Marks") and such Segregated Registered Marks shall constitute Trademark Collateral. Upon receipt of Certificates of Registrations of the Segregated Registered Marks for the Transferred Businesses, the Company will delete all goods and services from those existing registrations of the Shared Marks covered by the new registrations for the Segregated Registered Marks. For all non-registered Trademarks relating to the goods and services of the Transferred Businesses ("Segregated Non-Registered Marks"), the Company will also take all appropriate action and execute any and all documents and instruments to effect recordation of any security interest in the Segregated Non-Registered Marks. Any Shared Mark relating to the Transferred Businesses that has not become a Segregated Registered Mark constitutes Trademark Collateral and the Secured Party shall have a security interest in such Shared Marks to the extent the Secured Party has the right to use such Shared Marks pursuant to the License Agreement.

(i) Notices. The Company will advise the Secured Party promptly of any Lien (other than a Permitted Lien) on any of the Collateral and 30 days in advance of any change in location of the Company's chief place of business and chief executive office.

(j) Indemnification. The Company agrees to pay, and to keep the Secured Party harmless from, any and all liabilities with respect to, or resulting from any delay in paying any and all stamp, excise, sales or other taxes which may be payable or determined to be payable with respect to any of the Collateral or in connection with any of the transactions contemplated by this Agreement.

(k) No Future Filing of Shared Marks. Any application filed after the date hereof by the Company for registration of a trademark will solely relate to either the Retained Businesses or the Transferred Businesses and will not contain any description or classification of goods or services concerning both the Transferred Businesses and the Retained Businesses.

5. Secured Party's Appointment as Attorney-in-Fact. From and after an Event of Default, the Company hereby irrevocably constitutes and appoints the Secured Party and any officer or agent thereof, with full power of substitution, as its true and

lawful attorney-in-fact with full irrevocable power and authority in the place and stead of the Company and in the name of the Company or in its own name, from time to time, in the Secured Party's discretion, for the purpose of carrying out the terms of this Agreement, to take any and all appropriate action and to execute any and all documents and instruments which may be necessary or desirable to accomplish the purposes of this Agreement, including the segregation of Shared Marks.

6. Transfer of Collateral. From and after an Event of Default, the Secured Party shall thereafter be entitled, upon the Secured Party's request, and in the Secured Party's sole discretion to all rights, title and interest in and to the legal ownership of the Collateral, subject only to the prior rights reserved by the Company under the License Agreement to use the Retained Marks (as defined in the License Agreement) in the Retained Businesses. Upon the written request of the Secured Party the Company shall make a formal assignment and transfer to the Secured Party in recordable form of the Licensed Marks and all other rights in the Licensed Marks other than those rights to be excluded from such transfer pursuant to the prior sentence.

7. Remedies. (a) If an Event of Default shall occur and be continuing, the Secured Party may, in its sole discretion, exercise, in addition to all other rights and remedies granted to it at law or equity or in the License Agreement (including, without limitation, equitable remedies) or in this Agreement, all remedies of a secured party under the Code. The Company hereby agrees that it shall have no right to satisfy the Secured Party's rights to equitable remedies by the payment of money damages, and nothing contained in this Agreement will restrict the Secured Party's rights to obtain equitable remedies for breaches of the License Agreement. To the extent permitted by applicable law, the Company waives all claims, damages and demands it may acquire against the Secured Party arising out of the lawful exercise by it of its rights hereunder.

(b) Any absolute and unavoidable transfer of legal title to the Secured Party of all the Company's right, title and ownership interest in the Collateral made in satisfaction of the Secured Party's rights under this Agreement whether made as part of a voluntary transfer under Section 6 or involuntarily in a proceeding pursuant to subsection (a) of this Section shall constitute a full and final satisfaction and discharge of any claims of the Secured Party or any person claiming by or through the Secured Party for money damages against the Company pursuant to this Agreement to the extent that the damages related to the Collateral so transferred are recouped as a result of such transfer. In the event of a default or any litigation arising out of this Agreement each party will bear their own attorney's costs.

8. Duty of Secured Party. The Secured Party's sole duty with respect to the custody, safekeeping and physical preservation of the Collateral in its possession.

under the Code or otherwise, shall be to deal with it in the same manner as the Secured Party deals with similar property for its own account. Neither the Secured Party nor any of its directors, officers, employees or agents shall be liable for failure to demand, collect or realize upon any of the Collateral or for any delay in doing so or shall be under any obligation to sell or otherwise dispose of any Collateral upon the request of the Company or any other person or to take any other action whatsoever with regard to the Collateral or any part thereof. The powers conferred on the Secured Party hereunder are solely to protect the Secured Party's interest in the Collateral and shall not impose any duty upon the Secured Party to exercise any such powers.

9. Execution of Financing Statements. Pursuant to the Code, the Company authorizes the Secured Party to file financing statements with respect to the Collateral without the signature of the Company in such form and in such filing officers as the Secured Party reasonably determines appropriate to perfect the security interests under this Agreement. A carbon, photographic or other reproduction of this Agreement shall be sufficient as a financing statement for filing in any jurisdiction.

10. Severability. If any provision hereof is invalid and unenforceable in any jurisdiction then, to the fullest extent permitted by law, (i) the other provisions hereof shall remain in full force and effect in such jurisdiction and shall be liberally construed in favor of the Secured Party in order to carry out the intentions of the parties hereto as nearly as may be possible; and (ii) the invalidity or unenforceability of any provision hereof in any jurisdiction shall not affect the validity or enforceability of such provision in any other jurisdiction.

11. No Waiver; Cumulative Remedies. No failure to exercise, nor any delay in exercising, on the part of the Secured Party, any right, power or privilege hereunder shall operate as a waiver hereof or thereof. The rights and remedies herein provided are cumulative, may be exercised singly or concurrently and are not exclusive of any other rights or remedies provided by law or by any other agreement between the parties hereto.

12. Waivers and Amendments; Successors and Assigns; Governing Law. None of the terms or provisions of this Agreement may be amended, supplemented or otherwise modified except by a written instrument executed by the Company and the Secured Party. This Agreement shall be binding upon the successors and assigns of the Company and shall inure to the benefit of the Secured Party and its respective successors and assigns. This Agreement shall be construed in accordance with and governed by the laws of the State of Florida, without regard to the conflicts of laws provisions thereof.

13. Notices and other Communications. All notices, requests, consents and other communications hereunder shall be in writing and shall be addressed (i) if to the Secured Party, to its address for communications set forth in the License Agreement or to such other address as may have been furnished to the Company by written notice from the Secured Party, and (ii) if to the Company, to its address for communications set forth in the License Agreement or to such other address as may have been furnished to the Secured Party by written notice from the Company.

14. Counterparts. This Agreement may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same agreement.
