ASSIGNMENT

WHEREAS, Cessna Aircraft Company, a Kansas corporation (hereinafter "Cessna Aircraft"), has adopted, used and is using the trademarks described herein, along with the goodwill of Cessna Aircraft's business symbolized thereby, and is the owner of all right, title, and interest in and to the trademarks described herein, including any and all United States, state or foreign registrations issued, applications filed, common-law rights related to said trademarks, rights to obtain renewals and all other legal protections pertaining thereto;

WHEREAS, Cessna Aircraft desires to transfer all of its right, title, and interest in and to such trademarks, along with the goodwill of the business symbolized by and associated with such trademarks, to Cessna Aircraft Rhode Island Inc., a Delaware corporation (hereinafter "Cessna Aircraft Rhode Island");

WHEREAS, all transfers of intellectual property pursuant to this Assignment are intended to be transfers pursuant to Section 351 of the Internal Revenue Code of 1986, as amended (the "Code");

NOW, THEREFORE, to whom it may concern, be it known that for good and valuable consideration, the receipt of which is hereby mutually acknowledged:

1. THE ASSIGNMENT OF TRADEMARK RIGHTS AND THE ASSOCIATED GOODWILL BY CESSNA AIRCRAFT TO CESSNA AIRCRAFT RHODE ISLAND

Cessna Aircraft has assigned, and transferred, and by these presents, Cessna Aircraft hereby does assign, transfer, and deliver to Cessna Aircraft Rhode Island, its successors, assigns, and legal representatives the whole of any and whatever right, title, and interest Cessna Aircraft may have in and to: (i) the trademarks listed in Exhibit A, and any United States, state or foreign registrations of such trademarks, applications filed, common-law rights related to said trademarks, rights to obtain renewals and all other legal protections pertaining thereto; and (ii) the goodwill of Cessna Aircraft's business symbolized by and associated with the trademarks listed in Exhibit A.

2. FURTHER ASSURANCES

Cessna Aircraft and Cessna Aircraft Rhode Island hereby further agree, each for itself and its successors, assigns, and legal representatives, to execute upon request any other lawful documents and likewise to perform any other lawful acts that are necessary to secure fully the aforesaid rights, titles, and interests in and to said trademarks listed in Exhibit A to Cessna Aircraft Rhode Island, its successors, assigns, and legal representatives.
