TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment"), effective as of January 4 2005 (the "Effective Date"), is made by BANKFIRST, a state-chartered bank ("Assignor").

WHEREAS, Assignor is the current owner of U.S. Trademark Registration No. 2,592,132 for the Mark "ACTION CARD" registered July 9, 2002, and is also the current owner of the common law mark "ACTION GUARD" (hereinafter collectively referred to as the "Marks"), and

Assignor hereby transfers, sells, assigns, and conveys unto Assignee the Marks including all common law rights therein and all applications to register and registrations thereof and the goodwill that they represent, and all right, title and interest therein, on a world-wide basis, as well as the right to sue and collect damages in Assignee's own name for any and all past, present or future infringement, dilution, or other injury to the goodwill thereof.

2. Assignor agrees to execute and deliver to Assignee, or Assignee's designee, such instruments of transfer and other documents as Assignee may reasonably request to effect the purposes of this Assignment.
