The Plan of Merger is entered into by and between Specialty Brands of America, Inc. ("SBA"), a Massachusetts Corporation and its wholly-owned subsidiary, Spring Tree Corporation, a Vermont corporation ("Spring Tree").

1. Upon the effective time of the Merger, Spring Tree shall be merged into SBA, which shall be the surviving corporation, and the separate existence of Spring Tree shall cease.

2. The manner and basis of converting the shares of Spring Tree into shares, obligations, or other securities of SBA or any other corporation or into cash or other property in whole or in part is as follows:

(i) Upon the effective time of the Merger, all of the shares of common stock, without par value, of Spring Tree issued and outstanding immediately prior to the effective time of the Merger will be automatically canceled without payment of any consideration therefor.

3. Effective Date. The effective date of the Merger shall be December 2, 1999.
