ASSIGNMENT OF U. S. TRADEMARK

NOW, THEREFORE, in consideration of One Dollar and other good and valuable considerations, the receipt of which is hereby acknowledged, Assignor confirms that it has assigned and transferred, and by these presents does sell, assign and transfer unto Assignee the entire right, title and interest in and to the trademark and the registration thereof, and in and to the goodwill of the business in connection with which said trademark is used, the same to be held and enjoyed by the said Assignee, for its own use and benefit, and for the use and benefit of its successors, assigns or other legal representatives to the full end of the term for which said United States Trademark Registration has been granted or will be granted, as fully and entirely as the same would have been held and enjoyed by said Assignor, if this assignment had not been made; together with all claims for damages by reason of past infringement of said United States Trademark Registration, with the right to sue for, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives.

This assignment shall be considered effective as of July 2002.


