
Assignor hereby agrees to waive all rights and privileges to attack the registrations of the Marks.

Any and all reasonable expenses incurred by Assignor in connection with its obligations under this paragraph shall be paid by Assignee (or its assigns) provided, however, that Assignor has obtained the prior written consent of Assignee (or its successors or assigns) to incur the expense for which Assignor seeks payment.
