## TRADEMARK RELEASE OF SECURITY INTEREST

WHEREAS, a certain Subsidiary-Agent Security Agreement, Financing Statement and Assignment of Patents, Trademarks and Copyrights ("Agreement"), dated June 1, 1989 was entered into by Viskase Corporation, a Pennsylvania corporation and other entities known in the Agreement collectively as "Envirodyne Subsidiaries" ("Assignor") and Continental Bank, N.A., as agent ("Assignee"); and

WHEREAS, the Agreement is recorded in the United States Patent and Trademark Office at Reel 0659, Frames 0001 to 0047, with respect to certain United States trademarks ("Intellectual Property Collateral") as set forth on the schedule attached to this Trademark Release of Security Interest and to the Agreement; and

WHEREAS, the Agreement provided a collateral security interest in the Intellectual Property Collateral for certain loans made by Assignee to Assignor and such loans have been fully paid and satisfied; and

WHEREAS, Continental Bank, N.A. is succeeded in interest by the Bank of America, N.A., and Viskase Corporation is succeeded in interest by Viskase Companies, Inc.

NOW THEREFORE, for and in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee and its successor in interest and assigns does hereby terminate its security interest and, without representation or warranty, hereby assigns, sells, and transfers unto Assignor and its successors and assigns, its entire right, title and interest in and to the Intellectual Property Collateral, together with that part of the goodwill of its business connected with the use of and symbolized by the Intellectual Property Collateral, and does hereby further cancel and terminate the Agreement, declare the same null and void, of no further force and effect, and further states that Assignee and its successors and assigns has no further or continuing right, title, or interest in or to any of the Intellectual Property Collateral.


