TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (hereinafter "*Assignment*") is made effective as of this 3 day of AUGUST, 2006, by and between DevStreet, Inc., a Florida corporation (hereinafter "*Assignor*"), and Apptix Acquisition Subsidiary, Inc., a Delaware corporation (hereinafter "*Assignee*"). Assignor and Assignee are sometimes referred to herein individually as a "Party" or collectively as the "Parties."

WHEREAS, in connection with transactions contemplated to be entered into by the Parties, the Parties have decided to enter into a formal agreement assigning certain of Assignor's trademarks.

WHEREAS, Assignee wishes to acquire and Assignor wishes to assign Assignor's entire right, title and interest in (a) the United States Trademark registration identified and set forth on Schedule A attached hereto (the "*Mark*") and (b) the goodwill of the business associated with said Mark.

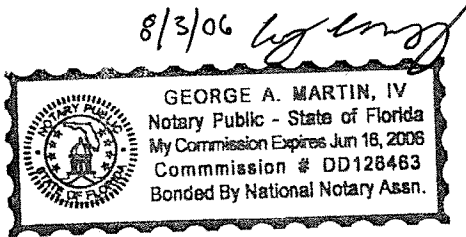
NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

Assignor does hereby sell, assign, transfer and set over to Assignee its entire right, title and interest in and to the Mark, together with the goodwill of the business with which the Mark is used, for the United States and all foreign countries, including any renewals and extensions of the registration that are or may be secured under the laws of the United States, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all income, royalties, damages or payments due or payable as of the date hereof or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for, and collect the same for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner of the Mark in the United States.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
