RELEASE OF SECURITY INTEREST -- TRADEMARKS

WHEREAS, Paribas ("Paribas") and QST Environmental, Inc. ("QST") are parties to a certain Security Agreement dated as of June 24, 1999 (the "Security Agreement"), recorded with the United States Patent and Trademark Office on August 18, 1999, at Reel 1947, Frame 0807, pursuant to which QST granted to Paribas a security interest in the trademark set out in Exhibit A hereto (the "Mark") and provided for the enforcement of such security interest; and
