RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE, dated as of July 7, 2006, is made by Harris N.A. (as successor by merger to Harris Trust and Savings Bank), as agent ("Harris"), in favor of Accretive Solutions, Inc. ("Accretive") as follows:

WITNESSETH

WHEREAS, pursuant to the Trademark Collateral Agreement, dated December 31, 2004 ("Collateral Agreement"), and recorded with The United States Patent and Trademark Office on January 3, 2005 at Reel/Frame No. 3001/0702, Accretive granted Harris a continued security interest in the following: (i) each trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark registration and application, and (ii) all proceeds of the foregoing, including without limitation any claim by Accretive against third parties for damages by reason of past, present or future infringement of any trademark registration listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark registration, in each case together with the right to sue and collect said damages (the "Trademark Collateral"),

WHEREAS, Accretive has requested that Harris release its security interest in all right, title and interest of Harris in and to the Trademark Collateral.



Harris agrees to provide Accretive with any information and additional authorization necessary to effect the release of Harris' security interest in the released Trademark Collateral.

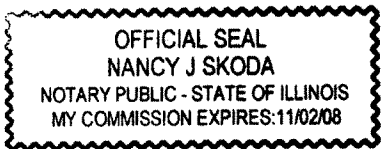
