RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "**Release**"), dated as of July 31, 2006, is made by Goldman Sachs Specialty Lending Group, L.P., as administrative agent (the "**Administrative Agent**") under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, INTEGRA TELECOM HOLDINGS, INC., an Oregon corporation ("**Company**") and the Administrative Agent entered into that certain AMENDED AND RESTATED CREDIT AND GUARANTY AGREEMENT, dated as of September 16, 2004, as amended and restated as of May 1, 2006, by and among Company, Administrative Agent, INTEGRA TELECOM HOLDINGS, INC., an Oregon corporation ("**Company**"), INTEGRA TELECOM, INC., an Oregon corporation, CERTAIN SUBSIDIARIES OF COMPANY, as Guarantors, the Lenders party hereto from time to time, Lead Arranger, Syndication Agent and Documentation Agent;

WHEREAS, in connection with the Credit Agreement, the Company and certain of the Company's subsidiaries granted security interests in certain intellectual property owned by the Company listed on Annex I attached hereto (collectively, the "**Trademark Collateral**"); and



WHEREAS, that certain Trademark Security Agreement, dated September 16, 2004, between Company and the Administrative Agent was recorded in the U.S. Patent and Trademark Office on October 4, 2004, and on the reel/frame 002950/0910 (the "**Security Agreement**");

NOW THEREFORE, the Administrative Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Trademark Collateral, whether granted pursuant to the Security Agreement or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Trademark Collateral to the Company.

The Administrative Agent agrees, at the Company's expense, to cooperate with the Company and its Subsidiaries and to provide the Company and its Subsidiaries with the information and additional authorization reasonably required or desirable to effect the release of the Administrative Agent's security interest in the released collateral described herein.
