RELEASE AND TERMINATION OF SECURITY INTEREST
IN TRADEMARKS AND PATENTS

This RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS AND PATENTS ("Termination and Release") is executed as of July 13, 2006, by Deutsche Bank AG London, a German corporation (the "Lender"), with reference hereby made to that certain Pledge and Security Agreement, dated as of March 5, 2004 (the "Security Agreement"), among Invensys Building Systems Inc., a Delaware corporation (the "Borrower"), and Lender (collectively, the "Parties").

WHEREAS, the Borrower has requested that the Lender release the liens and security interests granted to it in the right, title and interest in and to the trademarks and trademark applications of the Borrower, together with the goodwill of the business symbolized thereby, set forth on Schedule A attached hereto (the "Trademarks"), and the patents and patent applications of the Borrower, set forth on Schedule B attached hereto (the "Patents"), pursuant to the IP Security Agreements (as defined herein).

For good and valuable consideration, the receipt of which is hereby acknowledged:

The Lender does hereby certify that the security interests it holds in the right, title and interest to all of the Trademarks and Patents, pursuant to, respectively, that certain Trademark Security Agreement which was recorded with the United States Patent and Trademark Office on April 5, 2004 at Reel 2942, Frame 0360 and that certain Patent Security Agreement which was recorded with the United States Patent and Trademark Office on April 6, 2004 at Reel 015190, Frame 0297 (collectively, the "IP Security Agreements"), by and between the Parties, are released and terminated and all interests in such property previously assigned to the Lender under the IP Security Agreements are hereby reassigned to the Borrower, without recourse or representation or warranty, express or implied, of any kind.

This Termination and Release shall be governed by the laws of the State of New York and shall relate solely to the IP Security Agreements.
