- A. NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby expressly acknowledged, Assignor does hereby and herewith assign, transfer, sell and convey to Assignee all right, title and interest in and to the Trademark, together with the aforesaid U.S. Trademark or Service Mark Registration No. 2,033,087 therefor with all goodwill and consumer recognition symbolized by and embodied in all and any of the foregoing, all to be held and enjoyed by Assignee (and by Assignee's successors, assigns, and legal representatives) to the end of the term or terms for which the Trademark is granted and all and any renewals thereof, all as fully and entirely as same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all claims for damages and profits by reason of past infringement of the Trademark, with the right to sue for and collect same for Assignee's own use (and for the use of Assignee's successors, assigns, and legal representatives).

Assignor covenants and agrees that Assignor, on request, and at Assignee's own sole cost and expense, will execute and deliver to Assignee any and all documents and papers as may be necessary to perfect in Assignee the interests herein conveyed, and further covenants and agrees that Assignor, on request, and at Assignee's own sole cost and expense, will communicate and cooperate with Assignee to the extent necessary for Assignee to have and enjoy to the fullest extent the interest herein conveyed.
