
AFFIDAVIT

1. I am Treasurer and I have held this position since November 2001. Unless otherwise stated, I have knowledge of the facts set forth herein.
2. ClientLogic Operating Corporation (formerly known as ClientLogic Corporation, formerly known as CustomerOne Corporation, which was the name given to the company resulting from the merger of SSG Acquisition Corp. and Upgrade Corporation of America (doing business as Softbank Services Group)) is the owner of the trademark CLIENTLOGIC, Registration No. 2,657,596 which was filed in the United States Patent and Trademark Office on July 29, 1999 and registered on December 10, 2002.
3. I have been informed by legal counsel that at the filing date of the application namely on July 29, 1999, the owner of the trademark was identified as Softbank Services Group. That was in error. Softbank Services Group should have read ClientLogic Corporation, a Delaware corporation.

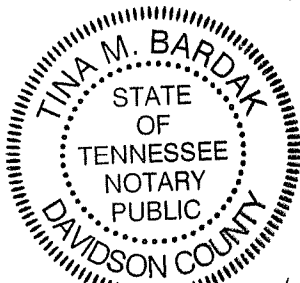
