## AFFIDAVIT OF WENDY HARMON

1. My name is Wendy Harmon. I am over 18 years of age and am fully competent to swear to this Affidavit. I have personal knowledge of the facts set forth herein. All of the facts set forth in this Affidavit are true and correct.

2. I was an employee of Paxson Broadcasting of Miami, L.P. ("Paxson of Miami") from at least as early as Spring 1992 through on or about July 17, 1997, the date of Paxson of Miami's merger with Paxson Communications Corporation, a Delaware Corporation ("PCC"). I was also an employee of Paxson of Miami's predecessor(s) in interest, who purchased Paxson of Miami on or about Spring 1992. My employment with Paxson of Miami's predecessor(s) in interest commenced at least 31 years ago.

3. Paxson of Miami was in the business of radio broadcasting, and owned at least five different radio stations in the Miami, Florida area.

4. The owner of Paxson of Miami ("Mr. Paxson") owned several radio stations in Florida that were managed or owned by limited partnerships ("Radio Partnerships"), one of those being Paxson of Miami.

5. I was made aware by the management of Paxson of Miami that in anticipation of selling all Radio Partnerships to a buyer, namely Clear Channel Metroplex, Inc., Mr. Paxson would be merging the Radio Partnerships, including Paxson of Miami, into PCC.

6. On or about July 17, 1997, Paxson of Miami merged into PCC, and thereafter PCC was the owner of all of Paxson of Miami's property. On or about July 17, 1997, the other Radio Partnerships were also merged into PCC.


7. Paxson of Miami's business of radio broadcasting was carried on by PCC for a short period, and soon thereafter or least as early as the Winter of 1997, Clear Channel

Metroplex, Inc. purchased PCC. At that time, I became an employee of Clear Channel Metroplex, Inc.


