## NUNC PRO TUNC ASSIGNMENT OF TRADEMARKS / TRADE NAMES

THIS NUNC PRO TUNC ASSIGNMENT OF TRADEMARK / TRADE NAME (the "Assignment") is made and entered into by and between EGL, Inc., (formerly Eagle USA Airfreight, Inc.) a Texas Corporation, with a principal place of business at 15350 Vickery Dr., Houston, Texas 77032 (the "Assignor"), and Eagle Partners L.P., a Texas limited partnership, formerly a Texas general partnership with a principal place of business at 15350 Vickery Dr., Houston, Texas 77032 (the "Assignee") consisting of EUSA Holdings, Inc., a Delaware corporation and Eagle Partners, Inc., a Delaware corporation, and confirms a previous verbal assignment between the parties.

WHEREAS, Assignor has adopted and used certain marks and trade names as of August 29, 1998 and may have adopted and used certain additional marks and trade names between August 29, 1998 and the date of execution of this Agreement, certain of which are identified on Exhibit A, and established certain goodwill in these marks throughout the world;

WHEREAS, Assignee is desirous of acquiring Assignor's marks.

NOW, THEREFORE, for good and valuable consideration of U.S. \$10 (ten dollars), the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign to the Assignee and Assignee hereby accepts nunc pro tunc as of August 29, 1998, all present and future right, title and interest in and to any and all marks owned, in whole or in part, by Assignor (collectively, the "Marks"), the goodwill of the business services and products symbolized thereby, and all rights of action accrued and to accrue under and by virtue thereof, including the right to sue and recover for past infringement of said Marks.

Assignor agrees that it shall, without additional compensation, execute and deliver further instruments of conveyance, transfer and assignment as requested by Assignee, its successors, or assigns, including documentation required to effectively convey, transfer and assign the Marks in applicable jurisdictions; reasonably cooperate and assist in providing information for making and completing regulatory and other filings; and take any and all other actions as Assignee, its successors, or assigns may reasonably require to effectively assign, convey, transfer, protect, enforce, and exploit the Mark, its associated goodwill, and all rights therein to Assignee, its successors, or assigns.

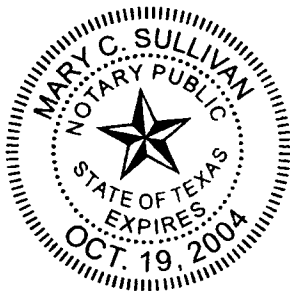

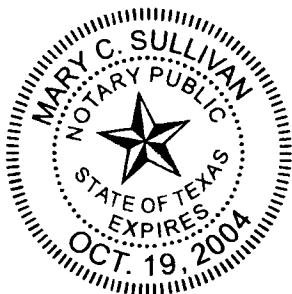
