## CONFIRMATORY TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is effective as of December 14, 2005 (the "Effective Date"), between DALMATIAN CORPORATION, formerly known as American LaFrance Corporation (the "Assignor"), and AMERICAN LAFRANCE LLC (the "Assignee").

WHEREAS, the Assignor and Assignee now wish to effectuate and confirm the assignment of all right, title and interest in and to the Marks from the Assignor to the Assignee.

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the Assignor hereby assigns, transfers and conveys unto the Assignee all right, title and interest in and to the Marks, together with the goodwill symbolized by the Marks, and the portion of the business to which the Marks pertain, said business being ongoing and existing, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns and/or other legal representatives.

The Assignor hereby authorizes the Commissioner of Patents and Trademarks to record the Assignee as the assignee of all right, title and interest in and to the Marks.
