Y RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of July 31, 2006 ("Effective Date") by and between **D.B. Zwirn Finance, LLC**, in its capacity as Administrative Agent ("Grantee"), as defined in the Security Agreement (defined below)) ("Grantee"), and **Extensity Merger Corp. (f/k/a Geac Computer Corporation Limited)**, **Extensity Canada Limited (f/k/a Geac Computer Corporation Limited)**, **Extensity, Inc. (f/k/a Geac Enterprise Solutions, Inc.)**, **Extensity (U.S.) Software, Inc. (f/k/a Geac Performance Management, Inc.)**, **Trisyn Group, L.P.**, and **Trisyn IP Limited** (collectively known as "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Short Form Second-Lien Trademark Security Agreement by and between Grantor and Grantee dated March 14, 2006 (the "Short Form Second-Lien Trademark Security Agreement"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on the Schedules to Short Form Second-Lien Trademark Security Agreement (the "Trademarks"), set forth on Schedule A attached hereto, together with the goodwill associated with or symbolized by the Trademarks; and all assets, rights and interests that uniquely reflect or embody the Trademarks;

WHEREAS, Grantor and Grantee entered into the Short Form Second-Lien Trademark Security Agreement pursuant to the terms and conditions of that certain Guarantee and Collateral Agreement by and between Grantor and Grantee dated March 14, 2005 (the "Security Agreement");

WHEREAS, the Short Form Second-Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on April 12, 2006, at Reel/Frame 3288/0412; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee, hereby terminates the Short Form Second-Lien Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks.

Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, Grantor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
