It is agreed that, when requested, ASSIGNOR shall, without charge to ASSIGNEE, but at ASSIGNEE's expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining intellectual property in any and all countries and for vesting title thereto in ASSIGNEE, its successors, assigns and legal representatives or nominees.

ASSIGNOR covenants to ASSIGNEE, its successors, assigns and legal representatives,
that it is fully authorized to convey the interest and property hereby conveyed.
