## **CONFIRMATORY SERVICE MARK ASSIGNMENT**



NOW, THEREFORE, for good and valuable consideration, previously paid by Assignee to Assignor, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign, set over and transfer unto said Assignee, *nunc pro tunc*, as of August 25, 2000, all right, title and interest in and to the ASSIGNED MARK and the identified registration therefor, together with the whole of the goodwill and the business symbolized by the ASSIGNED

MARK, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made; together with all claims for damages by reason of past infringement of the ASSIGNED MARK, and with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns or other legal representatives.

IN TESTIMONY THEREOF, said Assignor has caused its name to be signed and its seal to be affixed, by its duly authorized officer, this 14/14 day of August 2006.
