RELEASE OF SECURITY INTERESTS IN TRADEMARKS

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "Release") is made as of August 1, 2006 by and between Mobile Storage Group, Inc., Mobile Services Group, Inc., A Better Mobile Storage Company and MSG Investments, Inc. (collectively, "MSG") and BANK OF AMERICA, N.A. (the "Secured Party").

**WHEREAS**, MSG and the Secured Party entered into that certain Security Agreement, dated as of December 16, 2003 (as amended from time to time and as reaffirmed by that certain Reaffirmation Agreement dated as of December 30, 2005, the "Security Agreement");

**WHEREAS**, in connection with the Security Agreement, MSG and the Secured Party entered into that certain Patent and Trademark Security Agreement, dated as of December 16, 2003 between MSG and the Secured Party, as Administrative Agent (as amended, "Trademark Security Agreement"), pursuant to which MSG granted the Secured Party a continuing security interest in and continuing lien upon certain assets of MSG, including without limitation the trademark registrations set forth on Exhibit A (collectively, the "Trademarks");

**WHEREAS**, to record the Secured Party's security interest in the Trademarks, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on December 12, 2003 at Reel 2892, Frame 0981; and

**WHEREAS**, MSG has paid all of its outstanding indebtedness under the Trademark Security Agreement.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby releases, terminates and cancels any and all security interests and liens it has against, and reassigns all right, title and interest it may have in and to, the Trademarks, including without limitation, (i) all renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past, present or future infringements or dilution thereof, (iii) the right to sue for past, present and future infringements or dilution thereof, (iv) all rights corresponding thereto throughout the world, and (v) all goodwill of MSG's business connected with and symbolized by such Trademarks.

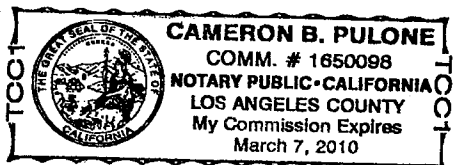
