From time to time, Assignor agrees, at Assignees request and without further consideration, to execute and deliver such instruments of sale, transfer, conveyance, assignment and confirmation, and to perform any other acts Assignee may reasonable request in order to more effectively sell, transfer, convey and assign to Assignee all of Assignors right, title, and interest in and to the Trademarks.

This Trademark assignment shall be governed by and constructed in accordance with the laws of the state of Vermont, without regard to the conflicts laws of that or any other state.
