("TBS"), CABLE NEWS NETWORK, INC. ("CNN"), TURNER PRORAM SERVICES, INC. ("TPSI") AND ATLANTA NATIONAL LEAGUE BASEBALL CLUB, INC.) ("ANLBC").

WHEREAS, ANLBC is the sole owner of all right, title and interest in and to the trademarks which are material to the conduct of its business as was then conducted and all of which are included on Exhibit A attached hereto and made a part hereof.


NOW, THEREFORE, in order to confirm the satisfaction and release of the performance of all Obligations (as defined in the Security Agreement), and for other good






