ASSIGNMENT FOR SECURITY - PATENTS AND TRADEMARKS

WHEREAS, Bacharach, Inc., a Delaware corporation ("Assignor"), owns the patents and patent applications, and the inventions disclosed or claimed therein and all continuations, extensions, divisions, renewals, substitutes or reissues thereof, listed on the annexed Schedule A (the "Patents"), which Patents are in full force and effect; and

WHEREAS, Assignor has adopted, intends to use or is using the trademarks listed on the annexed Schedule B (the "Trademarks"); and

WHEREAS, Assignor and Citizens Business Credit Company, a division of Citizens Leasing, Inc. ("CBCC"), entered into that certain Credit Agreement dated as of December 4, 1998, as amended (as amended, modified, and supplemented, the "Credit Agreement") pursuant to which CBCC made certain credit facilities available to Assignor; and

WHEREAS, in connection with the Credit Agreement, Assignor and CBCC entered into a Security Agreement and Mortgage-Patents, Trademarks and Copyrights dated as of December 4, 1998 (the "Intellectual Property Mortgage") pursuant to which Assignor assigned to Assignee, and granted to Assignee a mortgage on, pledge of and security interest in, all right, title and interest of Assignor in and to (i) the Patents and similar legal protection, both domestic and foreign, including all continuations, continuations-in-part, extensions, divisions, renewals, substitutes or reissues thereof; and (ii) the Trademarks, together with all good will of the business symbolized by the Trademarks, and the registrations or applications for registration thereof, and all proceeds of (i) and (ii) thereof, including, without limitation, any royalties, claims for past, present and future infringement and proceeds of sale or other disposition thereof (the "Collateral") to secure the payment of the Obligations (as defined in the Credit Agreement); and


WHEREAS, CBCC assigned to **CITIZENS BANK OF PENNSYLVANIA**, a Pennsylvania state chartered bank (the "Assignee"), all of its rights, title and interest in, to and under the Credit Agreement, the Intellectual Property Mortgage, the other Loan Documents and all of the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound hereby, Assignor does hereby further assign unto Assignee and grant to Assignee (for the benefit of the Assignee) a mortgage on, pledge of and security interest in the Collateral to secure prompt payment of the Obligations.




