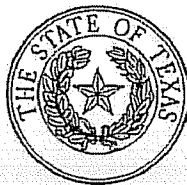

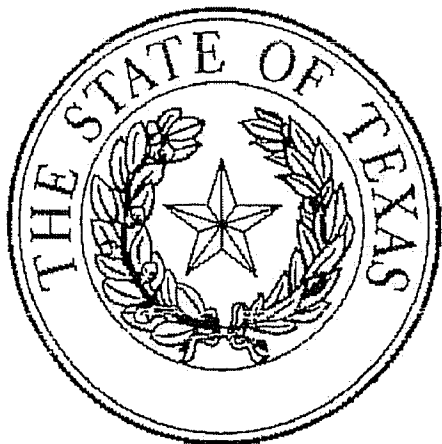

The holders of all of the shares outstanding and entitled to vote on said amendment have signed a written consent to said amendment, and any written notice required by law has been given.

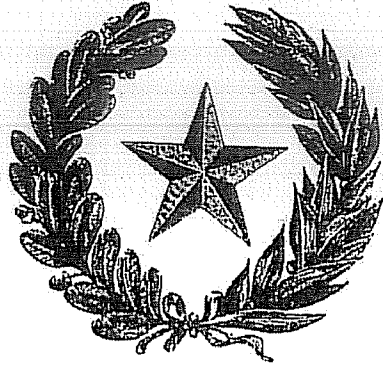

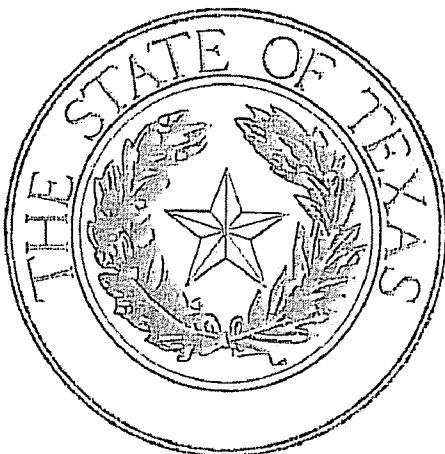

The name of the corporation is OneOffshore USA, Inc.”

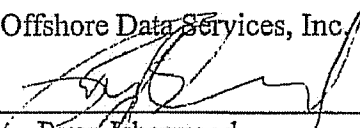
