SECOND LIEN TRADEMARK SECURITY AGREEMENT

SECOND LIEN TRADEMARK SECURITY AGREEMENT, dated as of June 28, 2006, by Data Device Corporation, a Delaware corporation ("DDC"), Beta Transformer Technology Corporation, a New York corporation ("Beta"), ILC Dover IP, Inc., a Delaware corporation ("Dover"), and ILC Dover LP, a Delaware limited partnership ("ILC LP", together with DDC, Beta, and Dover, the "Companies") in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as Collateral Agent pursuant to the Credit Agreement (as defined in the Security Agreement, defined below), as pledgee, assignee and secured party (the Collateral Agent, in such capacity and together with any successors in such capacity, the "Collateral Agent").

WHEREAS, each of the Companies has, pursuant to that certain second lien security agreement dated as of June 28, 2006 (the "Security Agreement"; capitalized terms used but not defined herein having the meanings assigned to such terms in the Security Agreement), made by ILC INDUSTRIES, INC., a Delaware corporation (the "Borrower"), ILC HOLDINGS, INC., a Delaware corporation ("Holdings"), and THE GUARANTORS PARTY THERETO (together with Holdings, the "Guarantors") and the Collateral Agent, as pledgors, assignors and debtors (the Borrower, together with the Guarantors, in such capacities and together with any successors in such capacities, the "Pledgors," and each, a "Pledgor"), in favor of the Collateral Agent, granted to the Collateral Agent for the benefit of the respective Secured Parties a security interest in and to all of the right, title and interest of such Pledgor, in, to and under the Pledged Collateral, including with respect thereto, the Trademarks, as collateral security for the payment and performance in full when due of the Secured Obligations; and

WHEREAS, the Companies and the Collateral Agent wish to further memorialize the security interest described above as it relates to the registered and pending U.S. federal Trademarks identified in Schedule A hereto, and incorporated herein by this reference, and the goodwill appurtenant thereto and all other rights appurtenant thereto, including but not limited to all products and proceeds thereof.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged and it being expressly understood and agreed that

the security interests granted herein for the benefit of the Collateral Agent on behalf of the respective Secured Parties shall be subject to the subordination terms of the Credit Agreement, the following security interest is hereby granted: as security for the payment or performance, as the case may be, in full of the Obligations, each of the Companies hereby pledges and grants to the Collateral Agent and its successors and assigns, for the ratable benefit of the Secured Parties, a second priority security interest in, all of such Company's right, title and interest in, to and under the registered and pending Trademarks identified in Schedule A, together with the appurtenant goodwill of such Trademarks. Notwithstanding anything herein to the contrary, the lien and security interest granted to the Collateral Agent pursuant to this Second Lien Trademark Security Agreement and the exercise of any right of remedy by the Collateral Agent hereunder are subject to the provisions of the Intercreditor Agreement. In the event of any conflict between the terms of the Intercreditor Agreement and this Second Lien Trademark Security Agreement, the terms of the Intercreditor Agreement shall govern and control.

The Collateral Agent shall be afforded the same rights, protections, immunities and indemnities set forth in the Security Agreement and the Credit Agreement (as defined therein) as if the same were specifically set forth herein.


