

- 1 Assignors **WALTER GRUBMÜLLER** of 5, Imp. de la Fontaine, Monte Carlo, Monaco 9800, Monaco;
- 2 Assignee **SCIENTIFIC GAMES HOLDINGS LIMITED** a company incorporated in Ireland with company number 378179 whose registered office is at Ground Floor, Embassy House, Herbert Park Lane, Ballsbridge, Dublin 4.

**BACKGROUND**

- A. The Assignor wishes to assign to the Assignee the Assigned IP.
- B. Accordingly, the parties have resolved to enter into this agreement.

**1 Definitions**

*Assigned IP*

(i) the patents, trade marks and utility models set out in the Schedule to this agreement and (ii) all other Intellectual Property owned by the Assignor in or relating to the Systems;

*GDL*

Global Draw Limited (a UK company);

*Group*

GDL, JDL, R&D, Neomi Associates Inc. (a British Virgin Islands company), Omnibet Limited (a Maltese company), Global Draw Kosova SH.P.K. (a Kosovan company) and Pagoda Leisure Limited (a UK company);

*Intellectual Property*

means all copyright and rights in the nature of copyright, database rights, design rights, inventions, patents, trade marks, domain names, applications for any of the above, moral rights, know-how, confidential information or any other intellectual or industrial property



rights, whether or not registered or capable of registration, whether now known or arising in the future, and whether subsisting in the United Kingdom or any other part of the world;

*JDL*

Jackpot Dream Limited (a UK company);

*R&D*

Research and Development GmbH, a company incorporated in Austria; and

*Systems*

means all betting and/or gaming systems operated by any member of the Group, including but not limited to:

(i) the "Global Greyhound System" software (which relates to the sale of computer software to produce, transmit and display pre-recorded greyhound races, depicting the result of a random number draw to computer terminals via a satellite centre system for betting purposes);

(ii) the "Global Greyhound Web Information System" software (which relates to the collection of data from JDL and JDL's customers' shops and premises for invoicing, bench-marking and other purposes in relation to the Global Greyhound System);

(iii) the "Quickdraw System" software (which relates to the sale and purchase of computer software to produce, transmit and display random numbers to computer terminals via a satellite centre system for betting purposes);

(iv) the "The Global Information



System" software (which relates to the collection of data from GDL and GDL's customers' shops and premises for invoicing, bench-marking and other purposes in relation to the Quickdraw System);

(v) all games created by or for a member of the group which are at a conceptual stage or other early stage of development, whether or not reduced to detailed proposals or designs or other recorded, including in particular, but not limited to the game known as "roulebet" and;

(vi) any other software/systems (including all games) operated by the Group and listed in the Schedule.

## 2 **Assignment**

In consideration of payment by the Assignee to the Assignor of the sum of £1, the receipt of which the Assignor hereby acknowledges, the Assignor hereby assigns to the Assignee with full title guarantee all the Assigned IP, for the full term thereof, together with the right to sue for, and recover damages in respect of, past infringements thereof.

## 3 **Further Assurance**

3.1 The Assignor agrees that it will, at the Assignee's reasonable cost, promptly execute any further documents, perform any further acts and give any assistance as the Assignee may at any time require:

- 3.1.1 to complete or record the Assignee's title to the Assigned IP;
- 3.1.2 to uphold the Assignee's rights in the Assigned IP; or
- 3.1.3 to defeat any challenge to the validity of, or resolve any questions concerning, the Assigned IP.

3.2 The Assignor will (at its own expense) promptly upon request deliver to the Assignee all drawings, designs, prototypes, documents and other materials (regardless of media) in their possession or control relating to the Systems.

3.3 The Assignor irrevocably appoints the Assignee to be his attorney and in his name and on his behalf to execute any documents and generally to act and to use their name for the purpose of giving to the Assignee (or its nominee) the full benefit of this clause 3. A certificate in writing signed by a director or the secretary of the Assignee that an instrument or act falls within the authority conferred by this clause shall be conclusive evidence in favour of a third party that it is the case.

#### 4 **Moral Rights**

The Assignor hereby waives his moral rights (including but not limited to all the rights referred to in Chapter IV Part 1 of the Copyright, Design and Patent Act 1988 and any similar, equivalent or analogous provisions of foreign law) in respect of the Assigned IP and warrant that all such moral rights have been waived.

#### 5 **Governing Law**

This deed shall be governed by English Law and the parties agree to submit to the non-exclusive jurisdiction of the courts of England and Wales.




