Aims and objectives: The aim of the company is to develop, produce, acquire and distribute products in the field of electrical and electronic engineering, in particular of telecommunications and data engineering, of weak current and power engineering, of medicinal engineering, of building engineering and of building management, as well as of machine tool construction, of instrument engineering and related fields of engineering; the design, execution and distribution of facilities and parts of facilities for generating, transmitting and processing information and energy and their application to production processes of all kinds; the production and distribution of goods for use as peripherals and consumables or as accessory appliances for the products thus manufactured or distributed and the provision of services, such as in particular consultancy, installation, maintenance and repair work. The company is entitled to undertake all forms of business and such measures as may appear to be necessary or useful for the purpose of achieving the corporate aims and objectives. For this purpose, it may acquire real estate property, run factories, found subsidiaries, establish, acquire or take part in other businesses, conclude corporate contracts and enter into joint ventures, both in Switzerland and abroad.

Comments:

- The extract transferred from a previous register card contains no facts deleted before the transfer and also no earlier data of any kind from the articles of association or quotations of any kind from the daybook and the Swiss Official Gazette of Commerce (SOGC). These may be examined in the Commercial Registry Card specified in the field headed "Transfer from".
- The company's communications to its shareholders are made through its publication organ. They may be made by registered letter, inasmuch as the

names and addresses of all shareholders are known to the Board of Directors and the law makes no obligatory provisions to the contrary.

- Merger: Takeover of the assets and liabilities of Siemens Building Technologies AG, registered office in Zurich (CH-020.3.924.055-6), in accordance with the contract of merger dated 21.09.2004 and the financial report dated 31.03.2004. The assets of CHF 1'171'085'555.-- and liabilities (borrowed capital) of CHF 577'333'494.-- are transferred to the company exercising the take-over. As the same shareholder holds all the shares in the companies involved in the merger, there is neither any increase in share capital, nor any allocation of shares.
- Operational office: Bellerivestrasse 36, 8008 Zurich.

Qualified facts:

- Took over the assets and liabilities of "Aktiengesellschaft Pfauen Zürich" in Zurich within the scope of a merger within the meaning of § 748 OR (Swiss Law of Contract); for further details, refer to Journal 10257/1978.
- Resolution dated 5.12.1984 to merge with "Belmag Zürich", Beleuchtungs- & Metallindustrie, Aktiengesellschaft in Zurich 3. Assets and liabilities according to the balance sheet dated 30.9.1984 were transferred to Siemens-Albis Aktiengesellschaft within the meaning of § 748 OR; for further details, refer to 2307/1985.
- Took over Alumag-Belmag AG in Zurich within the scope of the merger. The assets and liabilities of Alumag-Belmag AG were transferred to Siemens-Albis Aktiengesellschaft in accordance with the merger agreement of 14.11.1990 and merger balance sheet dated 30.9.1990 within the meaning of § 748 OR; for further details, refer to 5047/1991.
- CHF 1'000'000.00 of the nominal capital was paid by offsetting.
- CHF 9'000'000.00 of the nominal capital was paid from reserves.
- Merger: The company is to take over Schrack Components AG in Cham within the scope of a merger. Assets of CHF 1'211'108.66 and liabilities of CHF 126'547.62 are to be transferred to the company by universal succession in accordance with the merger agreement of 19.09.1996 and merger balance sheet dated 31.08.1996, whereby the company is already in possession of all the shares in the company taken over. These shares are thereby cancelled, and the nominal capital of the company performing the takeover remains unchanged.
- Merger: The company is to take over Siemens Integra Verkehrstechnik AG in Wallisellen within the scope of a merger. Assets of CHF 262'097'267.00 and liabilities of CHF 229'028'944.00 are to be transferred to the company by universal succession in accordance with the merger agreement of 27.11.1996 and merger balance sheet dated 01.10.1996, whereby the company is already in possession of all the shares in the company taken over. These shares are thereby cancelled, and the nominal capital of the company performing the takeover remains unchanged.
- Merger: The company is to take over Sauber & Gisin AG in Schwerzenbach within the scope of a merger. Assets of CHF 1'850'018.00 and liabilities of CHF 89'111.00 are to be transferred to the company by universal succession in accordance with the merger agreement of 26.11.1998 and merger balance sheet dated 01.10.1998, whereby the company is already in possession of all the shares in the company taken over. These shares are thereby cancelled, and the nominal capital of the company performing the takeover remains unchanged.

- Merger: The company is to take over Siemens Business Services AG in Kloten within the scope of a merger. Assets of CHF 68'370'068.00 and liabilities of CHF 45'870'068.00 are to be transferred to the company by universal succession in accordance with the merger agreement of 14.12.2001 and merger balance sheet dated 30.09.2001, whereby the company is already in possession of all the shares in the company taken over. These shares are thereby cancelled, and the nominal capital of the company performing the takeover remains unchanged.
- Merger: The company is to take over Telegyr Systems AG in Zug within the scope of a merger. Assets of CHF 17'821'246.00 and liabilities of CHF 31'762'489.00 are to be transferred to the company by universal succession in accordance with the merger agreement of 26.11.2002 and merger balance sheet dated 30.09.2002, whereby the company is already in possession of all the shares in the company taken over. These shares are thereby cancelled, and the nominal capital of the company performing the takeover remains unchanged.

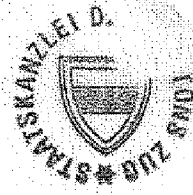
