

FUNK for his own use and benefit, and for his successors and assigns to the full end of the term for which trademarks may be granted in this or any foreign country, as fully and entirely as the same would have been held by LACE LINK CORPORATION had this assignment and sale not been made, and covenant that it has the full right to do so, and agrees that it will communicate to Douglas P. FUNK, or his successors and assigns, any facts known to it respecting said trademark application and testify in any legal proceeding, sign all lawful papers, make all

rightful oaths, and do everything possible to aid Douglas P. FUNK and his successors and assigns to obtain and enforce trademark protection for said application in this or any foreign country.
