ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, nunc pro tunc, as of February 19, 2004, all of its rights, title and interest in and to the Marks and the U.S. registrations therefor, together with the goodwill of the business symbolized thereby, and all rights of recovery for past infringement thereof; the same to be held and enjoyed by Assignee, for its own use and for the use of its successors and assigns, as the same would have been held and enjoyed by Assignor if this assignment and transfer had not been made.

Assignor warrants that there are no licenses, encumbrances, or other agreements, either written, oral or implied, relating to the Marks, and that it has good and valid title thereto to assign to Assignee.

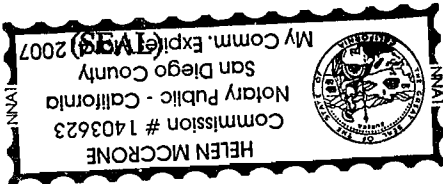
