Trademark Assignment

This **AGREEMENT** is dated as of August 15, 2006 between Kids on Ice, Inc., a Georgia corporation ("Assignor") and Friends of Fort Dupont Ice Arena, Inc., a not-for-profit corporation under section 501(c)(3) of the Internal Revenue Code, organized under the laws of the District of Columbia ("Assignee").

WHEREAS, Assignor owns rights, title and interest in and to the trademark **KIDS ON ICE**, used on and in connection with providing sports facilities for hockey and educational instruction in hockey, and the goodwill associated therewith, and is the owner of United States Trademark Registration No. 2,772,288 (the "Mark").

WHEREAS, Assignee is desirous of acquiring said mark and the foregoing registration;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns absolutely to Assignee and its successors and assigns all of its right, title and interest in and to the Mark, together with the goodwill of the business associated with, corresponding to, symbolized by and embodied in said Mark, U.S. Trademark Registration No. 2,772,288, and all common law rights in the Mark, as well as the right to commence an action for past or future infringement.

Assignor represents that (i) it is the owner of all rights, title and interest in and to the Mark, as defined above, and the goodwill associated therewith, and is the owner of United States Trademark Registration No. 2,772,288, (ii) its title in and to the Mark is free of any and all

encumbrances, liens or other adverse claims, (iii) said Mark has not been the subject of any license from or to any third party, and (iv) Assignor has the authority and right to make this assignment, and that the making of this assignment will not violate or interfere with the rights of any third party.

Furthermore, Assignor undertakes that:

- (a) It will perform all acts and execute all documents necessary or desirable for further assuring the right, title and interest to the Mark in Assignee, including the corresponding goodwill, and to U.S. Registration No. 2,772,288, and will cooperate with Assignee to record this Assignment with the United States Patent and Trademark Office, if necessary;
- (b) It will not commit any act, matter or thing that may directly or indirectly challenge, prejudice or invalidate the Mark, its use or registration by Assignee, its successors and assigns, or this assignment to Friends of Fort Dupont Ice Arena, Inc.
