WHEREAS, the Collateral Agent has exercised and continues to exercise its post-default and post-foreclosure remedies under the Loan Documents and applicable law, including the Uniform Commercial Code (the "UCC"); and

WHEREAS, pursuant to that certain Asset Purchase Agreement dated as of the date hereof by and between Collateral Agent and ULTRATECH, INC. ("Transferee"), and in accordance with, and under the protections afforded by, the Loan Documents and applicable law, including Section 9610 of California Commercial Code (the "UCC"), Collateral Agent has sold, assigned, transferred and conveyed to Transferee all right, title and interest in and to all of the Marks.

NOW, THEREFORE, in accordance with Section 9619 of the UCC, Transferee is entitled to a transfer of record of all rights of ORAXION, INC. in the Marks, and request is hereby made that the Commissioner of Patents and Trademarks and the United States Patent and Trademark Office [and any applicable foreign trademark office or agency] accept the foregoing transfer statement and promptly amend its records to reflect the aforesaid transfer to Transferee.


