INTELLECTUAL PROPERTY AND DOMAIN NAME ASSIGNMENT

This INTELLECTUAL PROPERTY AND DOMAIN NAME ASSIGNMENT (this "Assignment"), effective the 30th day of June, 2006, is made and entered into by and among SIEBEL SYSTEMS, INC., a Delaware corporation, SIEBEL SYSTEMS IRELAND HOLDINGS, LIMITED, an Irish company, ORACLE CORPORATION, a Delaware corporation, ONTARGET LLC, a Georgia limited liability company, ONTARGET (U.S.), INC., a Georgia corporation ("each an Assignor," and collectively, the "Assignors"), and SELECT SELLING LIMITED, an Irish registered private limited company ("Assignee") (each a "party," and collectively, the "parties"). Capitalized terms used but not defined herein shall have the meanings set forth in the APA (defined below).

WHEREAS, Assignors are the owners of the Intellectual Property included in the Transferred Assets described in the APA (the "Purchased Intellectual Property"), including, without limitation, the trademarks, trademark registrations and trademark applications (including any and all goodwill symbolized thereby) set forth on Schedule A hereto (the "Trademarks"), and the copyrights and copyright registrations set forth on Schedule B hereto (the "Copyrights"), and are the registrants of record and owners of each of the Internet domain names (including any and all goodwill symbolized thereby) and the domain name registrations therefor set forth on Schedule C hereto (the "Domain Names");

WHEREAS, Assignors and Assignee are contemporaneously entering into that certain Asset Purchase Agreement dated June 30, 2006 (the "APA"), pursuant to which Assignee agrees to purchase the Transferred Assets from Assignors, including all of Assignors' right, title and interest in and to the Purchased Intellectual Property; and

WHEREAS, the execution and delivery of this Assignment is a condition to Closing.

NOW THEREFORE, for the consideration set forth in the APA, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Assignors hereby sell, transfer, assign and agree to assign, and deliver to Assignee, its successors, legal representatives and assigns, Assignors' entire right, title and interest in and to the Purchased Intellectual Property, including, without limitation, the Trademarks, the Copyrights and the Domain Names, together with the goodwill of the business in connection with which the Purchased Intellectual Property has been used, and all registrations and applications therefor, in the United States and for all foreign countries, including any renewals and extensions of the registrations that are or may be secured under the laws of the United States and all foreign countries, now or hereafter in effect, and any and all rights to sue or recover and retain damages and costs and attorneys' fees for past, present and future infringement, dilution, misappropriation, or other violation thereof, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignors if this assignment and sale had not been made.

2. Conflicts. Nothing contained in this Assignment shall be deemed to alter or amend the terms and provisions of the APA, and in the event of any conflict between the terms and provisions of this Assignment and the APA, the terms and provisions of the APA shall be deemed to govern and be controlling.

3. Governing Law. This Assignment, and any claim relating to this Assignment, shall be construed in accordance with, and governed in all respects by, the internal laws of the State of Delaware (without giving effect to principles of conflicts of laws).

4. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which shall constitute the same instrument.


