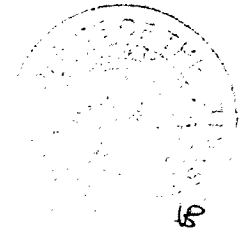
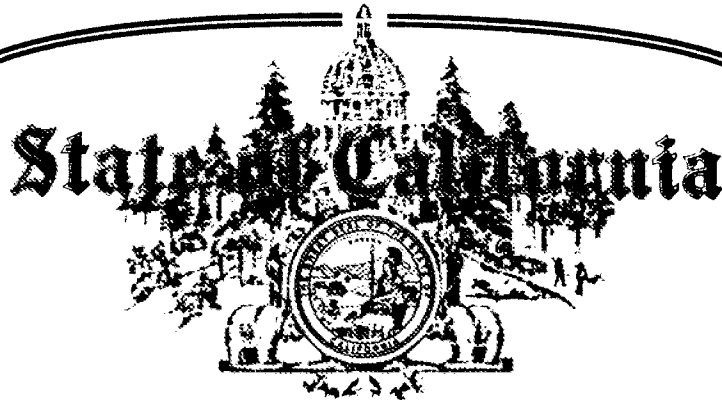

2. Article I of the Articles of Incorporation of said Corporation is amended to read as follows:


