COFFIN TURBO PUMP, INC., a Delaware corporation hereby certifies that:

- (1) The name and state of incorporation of each of the constituent corporations are:
 - (a) CARTER PUMP, INC., a New Jersey corporation; and
 - (b) COFFIN TURBO PUMP, INC., a Delaware corporation.
- (2) An agreement and plan of merger has been approved, adopted, certified, executed and acknowledged by the constituent corporations in accordance with the provisions of subsection (c) of Section 252 of the General Corporation Law of the State of Delaware.
- (3) The name of the surviving corporation, a Delaware corporation, is COFFIN TURBO PUMP, INC.

- (7) The authorized capital stock of CARTER PUMP, INC., a New Jersey Corporation, is 100 shares of common stock, no par value.
