DECLARATION OF SUSAN J. HINCHEY

I, Susan J. Hinchey, declare and state as follows:

1. I am Corporate Trademark Manager at Allergan, Inc. ("Allergan").
2. On July 28, 2006, Daniel Voorhees ("Mr. Voorhees"), a former paralegal at Allergan who was under my supervision, prepared an assignment document at my request to transfer certain marks owned by Collagen Corporation to Allergan, Inc. (the "Collagen Assignment").
3. When preparing the Collagen Assignment, Mr. Voorhees inadvertently identified 9 applications and registrations which were not owned by Collagen Corporation. A list of the 9 applications and registrations is attached hereto as Exhibit A.
4. After preparing the Collagen Assignment, Mr. Voorhees requested that Beki Osenbaugh ("Ms. Osenbaugh"), a temporary legal clerk at Allergan, (i) have the Collagen Assignment executed by authorized representatives of Collagen Corporation and Allergan, Inc., and (ii) electronically submit the executed Collagen Assignment under my name to the U.S. Trademark Office for recordal.
5. On July 28, 2006, Ms. Osenbaugh had the Collagen Assignment executed by authorized representatives of Collagen Corporation and Allergan, Inc. and electronically submitted the executed Collagen Assignment under my name to the U.S. Trademark Office for recordal against the applications and registrations identified in the Collagen Assignment, including the 9 applications and registrations identified on the attached Exhibit A.

6. The Collagen Assignment was recorded in the Assignment Branch of the U.S. Trademark Office under Reel/Frame 3357/0624 and a copy of such assignment is attached hereto as Exhibit B.

7. Because Collagen Corporation never owned the 9 applications and registrations shown on the attached Exhibit A, the applications and registrations shown on Exhibit A should not have been assigned to Allergan.

8. Because Collagen Corporation does not have the power to transfer an application or registration it does not own, ownership of the applications and registrations never transferred to Allergan.

9. I have identified on Exhibit A, for each of the 9 applications and registrations inadvertently identified in the Collagen Assignment, the correct owner of record in the Trademark Office as of July 27, 2006. Title to the 9 applications and registrations shown on Exhibit A should not be considered altered by the Collagen Assignment. The original applicant, registrant or the last correct assignee has been and continues to be the owner of the application or registration at issue.

10. This declaration is submitted in support of Allergan's submission to correct an error made in the assignment recorded at Reel/Frame 3357/0624 that erroneously affects the applications and registrations shown on the attached Exhibit A and is based upon my personal knowledge and upon the books and records kept in the normal course of business of Allergan.

I declare under penalty of perjury that the foregoing is true and correct.




