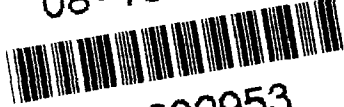



AFFIDAVIT OF MARK EPSTEIN

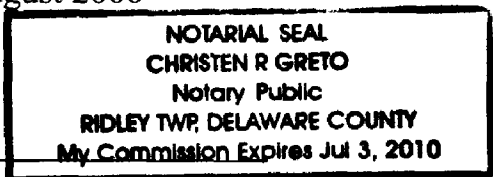
Mark Epstein, being duly sworn, states the following:
